TakingITGlobal will cease displaying my work within ninety (90) days after receipt of my Revocation Notice.

I agree that the Material may be cropped, edited and electronically manipulated or otherwise altered, and whether or how the Material is used is entirely for the TakingITGlobal to decide. I waive all moral rights in the Material in favour of TakingITGlobal and its assignees or licensees.

INTELLECTUAL PROPERTY

I certify that I am the sole owner of all intellectual property in the Material, and that I have obtained the consent for TakingITGlobal's use of the Material from all identifiable persons appearing therein.
